- iii. Nominated to serve as the congregation's representatives on the 2017 Nominating Committee:
 - o Lola Miller, Jan Ross, Janelle Wilson
- Moved by Kirk Cowman and seconded by Karen Dyck that nominations from the floor for Board of Elders be closed. Carried
- Tellers collected the ballots

10. LEAD PASTOR'S REPORT (Pastor Kirk Cowman)

- Pastor Kirk's report is recorded in the Annual Report 2016.
- The Pastor responded to the following questions from the floor:
 - 1. Could an ATM machine be installed in the building?
 - Measures and provisions for online giving are in place and intended to address a cash requirement.
 - 2. How is the Missions budget allocated?
 - Global missions 80%, Canadian missions 10%,
 Seamless Link 5%, Living Hope missions 5%.
 - 3. The term Director was used to refer to the Board of Elders with the following clarification:
 - A member of the Board of Elders is an Elder as per Scriptural requirements and is also a Director as per the Saskatchewan Non-profit Association Regulations.
 - 4. The new Pastoral position's status is pending. An offer was extended to a candidate, but due to sensitivities with respect to the offer process, an announcement cannot be made just yet.
 - 5. How does someone become a member?
 - An application must be completed by each prospective member. There is no transfer provision for members.
 - They must attend a class for incoming members. This may be waived for people coming from other Alliance Churches.
 - Two board members interview the candidates.
 - 6. Has our Membership number fallen?
 - With the relocation of the Filipino Church, the membership number has been reduced. However, apart from that event, there has been a steady increase in membership.

- 7. Is there a minimum age for membership?
 - When baptized, Youth can become a member. However, they cannot vote until the age of majority.
- Pastor Kirk also outlined Bylaw Revisions as follows:
- Change to Fiscal Year End the year-end is to change from December 31 to June 30. In an earlier recommendation the Finance Committee recommended that the date shift occur, subject to Board and CRA approval. This adjustment in year-end dates will necessitate that two audits be completed, one on December 31, 2017 and one on June 30, 2018. An additional interim budget will be required for the six-month period from January 1, 2018 to June 30, 2018 with a full 12-month budget for the new fiscal year July 1, 2018 to June 30, 2019. The additional audit requirement for this cycle will incur additional expenses that should be included in the six-month budget period ending June 30, 2018.
- <u>Board of Elder Succession</u> In order to provide continuity it is suggested that 2-3 members be added to the board each year.
- Moved by Kirk Cowman and seconded by Lola Miller that all Bylaw Revisions be approved.
 Carried.
- Moved by Kirk Cowman and seconded by Rick Orban that the Lead Pastor's Report be accepted.
 Carried.

BOARD DEVELOPMENT COMMITTEE

Mark Stefan, Chairman

Committee Mandate

Reporting to the Board of Elders, the committee is responsible for identifying and developing elders-in-training, orienting board members, and assisting the Chairman and Lead Pastor in equipping the board to fulfill their responsibilities. The committee is chaired by the Vice Chair and consists of the Vice Chair and the Lead Pastor who is an ex-officio member.

Board Development

The primary board development activity has been a focus on our relationships (Up, In and Out) led by our Lead Pastor, Kirk Cowman. It has been a very beneficial time. We also completed a study of the book "Building a Discipleship Culture" by Mike Breen.

On March 23, 2017, we conducted our Board Orientation. It included a review of the book titled "The Imperfect Board Member" by Jim Brown. It was an important session on board behavior, proper protocol and being men of God. Also, many board members were able to attend the Global Leadership Summit (GLS) in October, 2017.

We are in the process of selecting our next book to review with the board throughout the coming year. We are also anticipating that our board members will attend the GLS in October, 2018.

Elders-in-Training (EiT)

The purpose of this program is to prepare young men to lead as elders with heart, mind and soul. The elders' role is to provide insight and leadership to help these young men deepen their faith.

We were blessed to have six young men (Ryan Lett, Andrew Wilson, Brendan Bernakevitch, Tyler Chamberlain, Jim Haney and Jason Westgate) enrolled in this program as of November 18, 2016. The first formal session was held on January 26, 2017. The group was co-facilitated by Pastor Kirk Cowman and Mark Stefan. The group reviewed the book titled "Seven Men" by Eric Metaxas. They met monthly throughout 2017. They attended the first part of four board meetings, the AGM in March, the GLS in October, and also studied a number of topics.

We completed the inaugural year of this program at the end of December, 2017. One of our EiT members, Jim Haney, was led by God to let his name stand for nomination at the March 11, 2018 AGM. Two members have moved away - Jason Westgate to Calgary and Tyler Chamberlain to Manitoba. The remaining members enjoyed the program and will continue to consider involvement at the board level in the future. All of the young men enrolled in EiT provided valuable commentary regarding the program and its continuation.

The board is in the process of appointing a new Chairperson and developing the 2018 calendar. It will be a unique year with two year-ends in 2018. The desire is to align the EiT program with the LHAC board year.

Board Orientation

Our next board orientation session is to be held in March, 2018. No date has been set at this time. The purpose of this session is to cover a number of topics - qualifications for elders, duty and standard of care, C&MA and LHAC history and bylaws, LHAC Vision, Mission and Values, membership covenant, baptism, communion, spiritual gifts, missionaries, programs, budget, expectations to serve, board structure, etc.

Property Development Committee

Abe Toews, Chair

Since our last annual report the Property Development Committee and the Board have received and approved the Facility & Property Master Plan. This plan was developed by Pastor Kirk and the staff to match facility & property needs to the ministry goals for the next 5 - 10 years. As we stated in last year's report, the southeast Arcola area is expanding rapidly with a forecasted growth to over 42,000 people. There is no other land designated for church development in the Southeast Regina Neighbourhood Plan. In addition, there are major commercial developments happening, which include the completion of the By-Pass and ultimately Chuka Boulevard connecting to Highway #1.

In March the board approved the Master Plan for the development of the property as designed by Crosby Hanna. Proposals were requested from 2 engineering firms. The contract for design, tendering, and construction services was awarded to Clifton Associates. Clifton has extensive experience with our site as they have provided engineering services for drainage and overall site design. They started the design work in September and submitted preliminary designs in November and December.

Project costing estimates were provided in January 2018. The full project budget was estimated to be \$2,586,000 which includes a 15% contingency. After discussion by the committee and in consultation with Clifton, it was recommended to the Board that we complete the project in 4 stages with the budget for Stage #1 being set at \$1,500,000. Stage #1 will include paving of the largest portion of the parking lot, a new driveway onto Green Falls Drive, and landscaping. Once we know how successful the Going Beyond campaign is, we may complete Stage #2 (the parking lot to the east of the building) with some financing. Stage #3 is the parking lot on the west side of the building and Stage #4 is the development of the vacant land on Green Falls Drive.

The tentative schedule for Stage #1 is as follows:

March 2018 – Kick Off of the Going Beyond Campaign

April – May 2018 – Complete the site design

September 2018 – Tender the Project

October 2018 – Complete the financial plan

November 2018 – Award project to contractor

May – August 2019 – Complete Construction Project –

Stage #1

We are still working with the City of Regina to maintain the access to Arcola Avenue but are getting some resistance from them. Please pray that we can provide them with a strong case for keeping it.

The committee members are Dean Popil, James McCullough, Kirk Cowman, Rick Orban and Abe Toews.

We have been blessed and we thank God for the opportunity to serve the people of southeast Regina.



MINISTRY REPORT

Kirk Cowman, Lead Pastor

Two years ago we introduced a prayer that encapsulates what we desire God to do in our church family. We call it our Vision Prayer.

Father, by your Spirit:

Draw us close and create in us an unquenchable desire to sit at your feet and hear the whisper of your voice before all else.

Teach us the joy of living and learning in community. Unite us as a family of disciples that makes disciples.

Open doors into our community so that we may introduce Jesus and your Kingdom to our neighbours, city and world.

In the name of Jesus, we ask these things for your glory and our joy.

Amen

As we have prayed this over the last couple years, my question has been, "How will we know when this prayer has been answered? What will it look like in our church and how will it affect us personally?" We have identified six behaviors that we believe will be evident in us and our church family when our vision prayer is answered.

The six core behaviors that will be evident in Living Hope when our vision prayer is answered are: Prayer-Focused, Spirit-Empowered, Disciple-making, Loving Relationships, Creative Engagement and Meaningful Impact. Below you will find a brief definition of each behavior and my thoughts on how we are doing in each area. I've assigned one of three "gradients" to each of the behaviors to help us identify how we are doing at growing in these areas. The gradients are:

- "sprouting" the behavior is just starting to be developed.
- "growing" the behavior is developing and growing in strength
- "bearing fruit" the behavior is an area of strength and is evident in all we do.
- "pruning" actions may be needed to be taken in order to prepare to bear more fruit.

Prayer-Focused – *Growing*

Being Prayer-Focused means that we live each moment in continual conversations, talking with and listening to our heavenly Father. As a church family it means we will do nothing until we have heard from God.

As we look at the first church described in the book of Acts we discover that every significant movement of the church began with prayer. The church was praying when Holy Spirit came on them and enabled them to reach 3,000 people with the message of Jesus in Acts 2, and it happens again in Acts 4. The gospel spreads to the Gentiles after Peter is praying and has a vision in Acts 10. Paul and Barnabas are set apart as missionaries when leaders of the church in Antioch pray in Act 13. Again and again the mission of God in the church is advanced when the church prays.

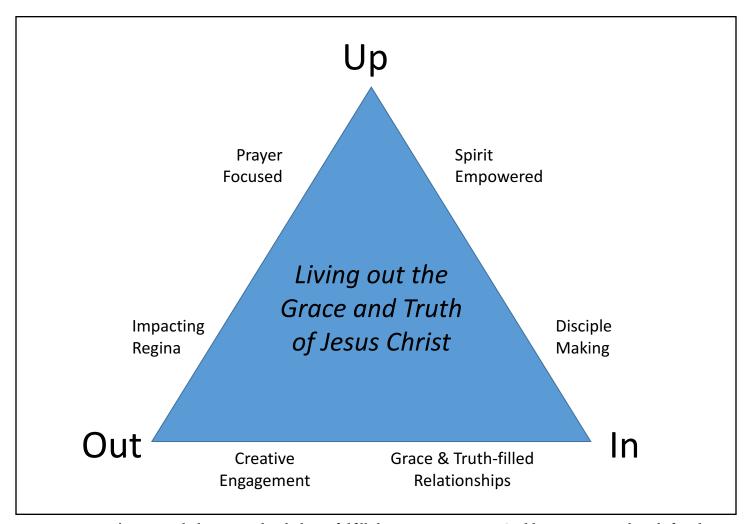
Through prayer we align ourselves with the heart of God. If you want to know the will of God for your life, it starts with prayer. If Living Hope is to become what Jesus envisions it is going to start with prayer. Our commitment and engagement in prayer continued to grow last year.

In 2017,

- We hosted 9 Prayer Summits on the last Sunday of the month, with an average attendance of 30 people attending. While there is a consistent group gathering to pray regularly, it represents only 10% of our adult weekend attendance.
- We began teaching about listening prayer through the 'Holy Spirit Encounter' weekend last February. This February's 'Holy Spirit Encounter' continued exploring listening prayer as we explored prophetic ministry (speaking God's truth into each other's life). In 2017 our 'Holy Spirit Encounter' had 50 participants and our latest one had 75 participants, representing 16% and 25% of adult weekend attendance.
- Small groups and serving groups were encouraged to begin and end their gatherings with prayer. Some began spending up to a quarter of their gathering time in prayer.

In 2018,

- Children's ministry will focus on teaching children how to pray so they are confident in prayer, as classroom leaders are encouraged to take time to pray with and for kids and their needs.
- We have started a new group on Sunday mornings in which there is a brief teaching on prayer followed by time to listen to God and pray for each other. If you'd like to learn how to pray and listen to God, then this group is for you.
- We will offer a six-session seminar on listening prayer, with each session including "lab" time to practice what you have learned.
- We will develop a team of people who will minister in prayer to others after weekend services.



Living Hope's six core behaviours that help us fulfill the unique purpose God has given our church family.

Spirit-Empowered – *Growing*

Spirit-empowered refers to living each day in the fullness and power of the Holy Spirit, letting him guide us, change us and empower us to live as Jesus envisions. Through the power of the Holy Spirit we can live lives that are increasingly free from sin and more like Jesus, while also taking our place in the mission of God.

Jesus promised his disciples that the Holy Spirit would come when He left. The Holy Spirit would enable them to continue the work He began. It is the Holy Spirit who led and empowered the disciples and the church to do the amazing things we read about in the book of Acts. Until the Holy Spirit came, all the first church could do was pray, but when He came and filled them, they were empowered for ministry and the world was changed. Each of us needs to be continually filled with the Spirit if we are to become what Jesus envisioned, and if we as a church are to continue Jesus' work today.

In 2017,

- We hosted our first 'Holy Spirit Encounter' weekend, which featured teaching on the person and work of the Holy Spirit and "lab" time dedicated to learning how to listen to the Spirit.
- 12 senior high teens attended 'Legacy Youth Conference' and experienced the presence of the Holy Spirit leading them to spend 3 hours in praying, confessing sins and encouraging each other, rather than attending one of the entertainment rallies.
- 5 junior high teens attended a 'Holy Spirit Encounter' weekend specifically designed to teach youth about the Holy Spirit. While there, one youth with an injured hand was healed.
- We continued to teach on the Holy Spirit during our weekend gatherings, through our 'Becoming' series. We regularly invited attendees to experience a fresh filling of the Holy Spirit and listen for his leading.

In 2018,

- We will host our second 'Holy Spirit Encounter' weekend featuring Dr. Rob Reimer of Alliance Theological Seminary. Holy Spirit Encounters will be a part of our annual rhythm, taking place each February.
- We will continue to introduce teens to the ministry of the Holy Spirit in their lives. We will seek for ways to introduce grade school children to the ministry of the Holy Spirit in an age-appropriate way.
- The pastoral staff will receive further training from Dr. Reimer, specifically in the area of soul care. 'Soul Care' explores seven principles that are profound healing tools of God: securing your identity, repentance, breaking family sin patterns, forgiving others, healing wounds, overcoming fears, and deliverance.

Disciple-Making – *Growing*

In Matthew 28:19-20, Jesus charges every believer to help others discover relationship with him and become passionately devoted disciples. We are to be disciples who make disciples, who make disciples.

Two years ago we created a discipleship strategy that identified four stages of growth that every disciple of Jesus goes through: Exploring, Discovering, Growing, and Surrendering. Since the creation of the discipleship strategy we have been creating engaging environments for each category with the goal of facilitating growth. Central to our discipleship strategy are our groups, which are core to every age-specific ministry at Living Hope.

Children's ministry and Youth ministry both make use of large and small groups in their ministries. Groups Ministry ministers specifically to adults, making use of longer-term groups meeting in people's homes as well short-term groups such as Alpha, Starting Point Groups and the Marriage Course which meet during MidWeek (Wednesday nights). It is our goal that everyone who calls Living Hope home would participate in a longer-term or short-term group each ministry year. Approximately 40% of adults at Living Hope currently participate in some type of group experience.

In 2017,

- A Young Adults men's breakfast group grew from 2 to more than 10, meeting every Wednesday morning at 6am to pray together.
- Groups Ministry created small group curriculum for every sermon series in the regular ministry year (September to June), as well as a list of recommended studies for use between sermon series curriculum.
- We began offering the recently revised Alpha program, for people who are exploring faith and discovering relationship with Jesus.
- The Marriage Course was offered twice and inspired couples with a vision of God's plan for marriage.
- Groups Ministry began offering regular coaching and training to all small group leaders.

In 2018,

- Children's ministry will focus on helping kids become confident with Scripture by providing age-appropriate Bibles for children to use during large group Bible time and in small group classroom time.
- Youth ministry will create and implement a discipleship pathway to assist youth in transitioning from high school to university and career (young adults ministry).
- Groups Ministry will be creating connecting events in the fall to help people connect with new small groups.
- The teaching team will prepare and deliver sermon series focused on apologetics (explaining your faith), about who Jesus is and intimacy with God.
- We will expand MidWeek offerings for adults with 4-6 week groups focused on helping those in the Growing and Surrendering categories grow in their faith.
- We will launch a tool to help individuals recognize where they are in our discipleship categories, and to identify possible next steps to grow in their faith.

Loving Relationships / Grace & Truth Filled Relationships - Bearing Fruit

Jesus lived a life that was marked by love, expressed in his relationships through grace and truth. Grace is unmerited favour given to someone in the form of forgiveness, love, and respect even when it isn't warranted. Truth is the knowledge of what God says about life. When we lean too much towards grace, everything is permissible and if we lean too much towards truth we become judgemental. Jesus constantly balanced grace and truth in his relationships and he invites us to do the same. When we follow His example, relationships are transformed, lives are transformed, and we become what Jesus envisions.

In 2017,

- Comments about the friendliness of the church was a dominate theme on first-time guest surveys.
- Four' Families Connect' Lunches and three 'Newcomers' Lunches offered environments designed to help build relationships between people of Living Hope.
- Our MidWeek program offered a healthy low-cost meal each week. This created opportunities for families to share a meal together and/or build relationships with other families at Living Hope.
- Extended time was given during the weekend service to provide opportunities for attendees to greet and get to know each other.
- Our 'Good Neighbour' teaching series focused on equipping each of us to live like Jesus did with the people next door, in the community, cubicle or classroom.
- More than 100 people attended our weekend services for the first time. We saw a 28% estimated retention rate (guests becoming regular attendees) and a year-over-year attendance growth of 3.2%.

In 2018,

- Youth ministry will intentionally focus on building relationships during their small group times, to improve relationships between youth and also between youth and leaders.
- Children & Family Ministry will provide a monthly video update from Pastor Shauna to all leaders to encourage and foster greater connections between leaders.

- We will explore creating a 'coffee and play time' during the week for stay-at-home parents to bring the kids. This will be a time when the children can play together and the parents can share a cup of coffee.
- We will continue to create environments where individuals and families can connect, such as 'MidWeek meal', 'Families Connect lunches' after weekend services and 'Newcomers lunches'.
- A marriage mentoring ministry will be developed to complement the 'Marriage Course' and facilitate healthy marriages in the community and church.

Creative Engagement – Sprouting

Creative Engagement refers to how we engage those around us with the message of hope found in Jesus Christ. We live in a world that is increasingly post-Christian. The common sentiment is "We have heard it all before." As a church family, we need to be creative in how we reach and engage with those who "have heard it all before." While significant progress has been made in this area, I believe we still have a way to go in creatively engaging people who are far from God.



In 2017,

- We created an engaging Easter Celebration which welcomed 450 people on Easter Sunday. This number was significantly more than have attended an Easter service over the past decade.
- We created fun and inspiring Christmas Eve services which welcomed over 800 people from our community.
- Summer activities such as 'Maker Fun Factory' Kids Camp in July ministered to 140+ kids. 'Play in the Park' days connected with parents and children on neutral ground.
- Over 150 marketplace and church leaders attended the 'Global Leadership Summit' and were inspired to be better leaders with a grander vision for their organization.
- We began holding 'Question and Answer' times after the sermon periodically; attendees were invited to text in questions during the sermon and the speaker responded to questions immediately after they finished speaking. These Q&A times were well received by attendees, particularly by millennials, and will become a re-occurring feature in our weekend services going forward.

In 2018,

- We will create a second service that will be more traditional in format and geared towards an older demographic. Our hope is that this service will attract residents of the soon-to- be complete Rivera Housing complex, as well as others from the community.
- Our Worship & Creative Arts ministry seeks to engage worshipers through drama and engaging stage designs that add to the service's theme. A drama team and stage design team will be formed to facilitate these initiatives.
- As part of the 'Going Beyond' campaign we will begin laying the groundwork for a new expression of Living Hope to be planted in the Greater Regina Area.
- In the fall we will expand our Preschool by adding a half-time teacher and two classes. Over the last two years we have had full classes and last year we had a wait list that was equivalent to one and a half classes.

Meaningful Impact / Impacting Regina – Growing

In Acts 1:8, Jesus said that his disciples were to be witnesses for him in Jerusalem, Judea and Samaria, and to the ends of the world. As Jesus' disciples today, our church family has been entrusted with carrying on Jesus' Acts 1:8

vision. It is our desire to make a meaningful impact in Regina and the world for the mission of Jesus Christ.

Last year we were full of ideas of what we could do, and we watched with excitement as doors began to open for us to make a meaningful impact in our community. I believe significant progress has been made in this area over the past twelve months.

In 2017,

- Children and Family Ministries developed a growing partnership with Arcola Community School. This led to a food drive, a clothing drive, gift bags at Christmas, and two volunteers who assist EAL readers.
- Youth ministry served our neighboring community, The Greens on Gardiner, by picking up litter around the neighborhood.
- Over \$5,000 was given to two women's shelters in Regina that are helping women to break free from addictions, abuse, sexual exploitation and poverty.
- 3952 sandwiches were made for the Salvation Army's Haven of Hope lunch program
- 40 families were fed through the means of grocery cards or food hampers.
- Over 1,000 community events were hosted in our facility, including family celebrations, city counsellor meetings, condo association meetings, dance classes, volleyball practices, and school concerts. These contacts have led to many opportunities for the Gospel to be shared in word and in deed.
- We funded the education of 40 teens in Kenya, enabling them to graduate from high school and pursue meaningful employment, which will help end the cycle of poverty in that country.
- Over \$100,000 was given to further God's mission globally, through C&MA International Workers, Compassion Canada and the Global Leadership Summit/Willow Creek Association.

In 2018,

- We will form a Compassion Team who will focus on caring for people in need both within our church family (internal people care) and in our greater community (external people care). This team will be different than our Compassion Connection team which focuses its efforts on the eradication of poverty in Regina.
- We will form a Missions Team who will promote Global Missions within our church and coordinate communication and trips with Living Hope's missionaries (Seamless Link partners and specific C&MA workers who partner with us). The Missions Team will also seek to provide care and support to Living Hope Missionaries while they are on the field.



- Through our' Going Beyond' initiative we will partner with the Willow Creek Association to expand the reach of The Global Leadership Summit on the Island by making it possible for 40 marketplace and church leaders to attend.
- We will send a team to "The Island" to assist our Seamless Link Partner in training and equipping marketplace and church leaders.

Since introducing the Vision Prayer two years ago, God has been at work in our church family, but there is still much more that He wants to do in and through us. I invite you to join with us in praying Living Hope's vision prayer regularly, and letting God work in and through you to make this prayer a reality.

Thank you for being part of the Living Hope family in 2017 and helping us become what Jesus envisions.

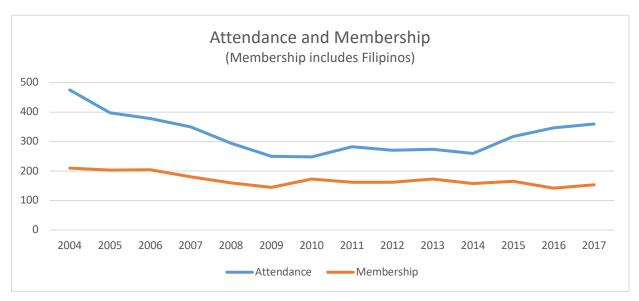

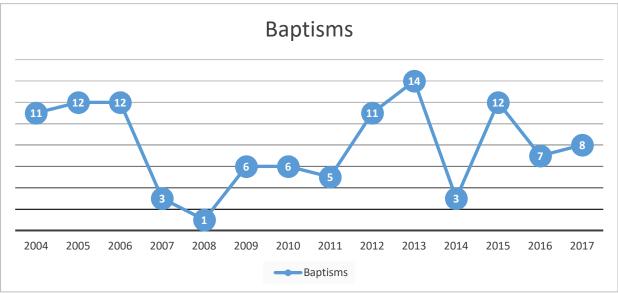

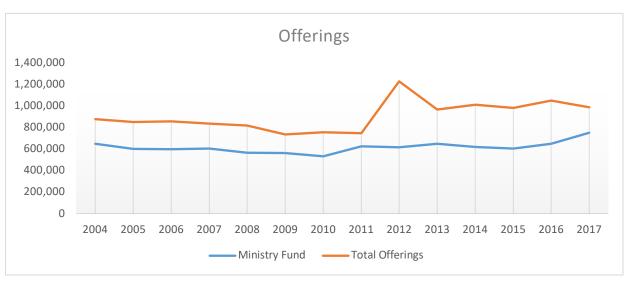

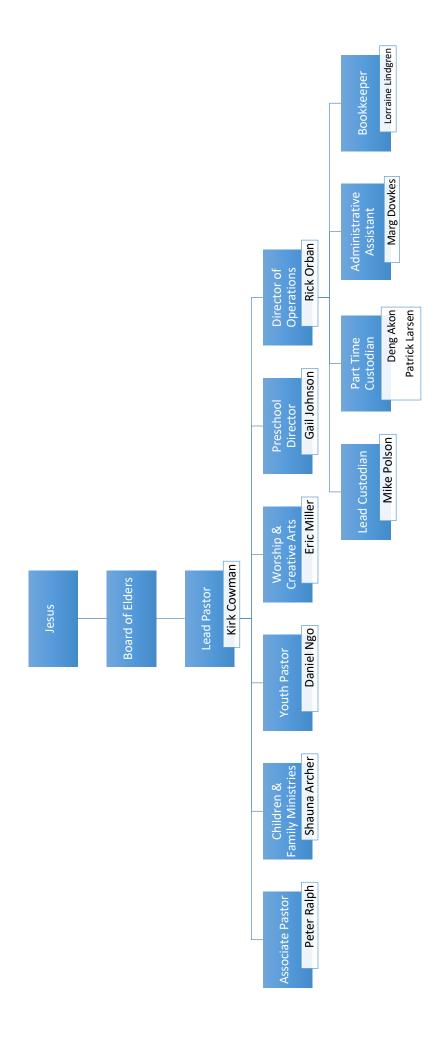








2018 Organizational Chart
